How can we find the underlying reason that the problem exists, and how can we communicate to management a plan to address that root cause? The OSHA onsite consultation program has an analysis method, a part of it's consultation (management) system assessment tool (CSAT). Starting with the list of deficiencies from a walkaround inspection, the list can be analyzed until they key management functions impeding progress can be identified. Now we can work with management to really make safety improvements.*
